COUNTY	LOCATION	EFFECTIVE	FLAVORS	CONDITIONS
ALAMEDA	BERKELY	1-Jan-17	All	Applies only to stores within 600 foot radius of schools.
CONTRA COSTA	CONTRA COSTA UNINCORPORATED	1-Aug-17	All	Applies only to stores within 1000 foot radius of schools.
CONTRA COSTA	EL CERRITO	1-Jan-18	All, except menthol cigarettes	Applies only to stores within 500 foot radius of schools.
ALAMEDA	HAYWARD	1-Aug-14	All	Applies only to stores within 500 foot radius of schools. Excludes Tobacco stores that sold flavored tobacco products prior to date of ordinance.
SANTA CLARA	LOS GATOS	1-Jan-18	All	Provides an exemption to retailers that: (1) derive 60% or more of gross revenue from tobacco sales (2) restrict access to premises to individuals 21+ (3) do not sell food or alcohol for consumption on premises.
LOS ANGELES	MANHATTAN BEACH	1-Jan-16	All except Mint, Menthol, Spearmint, Wintergreen Tobacco Products	Only applies to store within 500 foot radius of schools. The prohibition does not apply to a retailer that permits only patrons 21+ or older or active military personnel who are 18+ to enter the location where the product is sold.
MARIN	NOVATO	1-Jan-18	All, Except Menthol Tobacco Products	Unless (1) The product consists of a package of cigars containing at least 5 cigars or more (2) The tobacco product consists of a single cigar for which the retail price exceeds five dollars (3) The tobacco product consists of pipe tobacco (4) The tobacco product consists of a package of chewing tobacco or snuff containing at least five units or more.
ALAMEDA	OAKLAND	18-Jul-18	All	Exempts Tobacco Stores (stores where tobacco products account for 60% or more of sales), does not permit any person under 18 to be present or enter unless accompanied by parent or legal guardian, and does not sell alcoholic beverages or food for consumption on the premises.

ALAMEDA	SAN LEANDRO	15-Aug-18	All, except menthol cigarettes	All store types.
SANTA CLARA	SANTA CLARA UNINCORPORATED	1-Jul-17	All	Exempts Tobacco Stores (stores where tobacco products account for 60% or more of sales), does not permit any person under 21 to be present or enter unless accompanied by parent or legal guardian, and does not sell alcoholic beverages or food for consumption on the premises, and posts a sign outside that states persons under 21 years of age are prohibited from entering.
SONOMA	SONOMA	Jan-18	All, except pipe tobaccos and menthol tobacco products.	Unless (1) the tobacco product consists of a package of cigars that contains at least five cigars or more, or (2) a single cigar for which the retail price exceeds \$5.00, or (3) the tobacco product consisting of pipe tobacco, or (4) the package of chewing tobacco or snuff contains at least five units or more.
YOLO	YOLO UNINCORPORATED	1-May-17	All	All store types.
